Phokwane Local Municipality invites tenders for the upgrade of waste water pump stations and bulk outfall lines in Pampierstad.

Tenderers should have specific experience of the work for which a bid is submitted with a CIDB grading of 4CE and 4ME or higher for the appropriate tenders. Potentially emerging enterprises who satisfy criteria stated in the Tender Data may submit tender offers.

Only tenderers who are registered with the CIDB under a CE and ME grading are eligible to submit tenders.

Only tenderers who employ staff which satisfy EPWP requirements are eligible to submit tenders.

A non-refundable tender deposit of R 500.00-00 payable in cash made out in favour of the Phokwane Local Municipality at cashiers. **Payment receipt required on collection of the tender documents at SCM office.**

If the document is downloaded, payment must still be made and proof of payment must be attached with submission.
