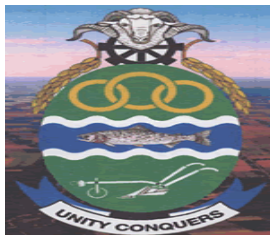

This Tender will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations, 2022 pertaining to the PPPF Act (No 5 of 2000) and the Supply Chain Management Policy and Preferential Procurement Policy 2023 of Phokwane Local Municipality. Phokwane Local Municipality is not bound to accept the lowest bid or award a contract to the bidder scoring the highest points. The Municipality reserves the right to partial acceptance of one or more bids, to withdraw any invitation to tender and/or to re-advertise or to reject any tender.

A maximum of 20 points (80/20 preference points system) will be allocated for specific goals. These goals are: Contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender or disability, 50% of the 20 points will be allocated to promote this goal. The other 50% of the 20 points will be allocated to promote the goal of Local labour and/ or promotion of enterprises located in the municipal area.

Tender should be clearly marked: (Bid Number and description) and must be deposited into the tender box situated at municipal main office, 24 Hertzog Street, Hartswater, Ground floor on or before the 4th of April 2025 before 12:00 pm.

Scope of work

1. Scope

This Bid is for Provision of security services for Phokwane Local Municipality for a period of 36 months.

We hereby request the service providers to quote for the above-mentioned tender through a competitive bidding process.

SCOPE OF WORK

The preferred bidder's prime objective is to provide a safe environment and to protect the property, personnel and information of Phokwane Local Municipality against theft, damage, unlawful occupation, trespassing and any other criminal activity. Phokwane Local Municipality requires services of trained security personnel to perform duties at the premises occupied by the department. The security services shall be provided on the property of PLM and shall in general entail the patrolling of premises, access control, control of assets, escorting of personnel and/ or members of the public where required and protection from and/ or to buildings and general crime prevention measures as agreed upon. The guarding function should relate to the seven (7) essential and interdependent elements of a physical security system i.e.

- Physical Security
- Monitoring Procedure
- Access Control
- Patrol Procedure
- Fire Control and Detection
- Contingency Planning
- Escorting

In order to safeguard the premises and the contents thereof as well as the people therein or thereon, the bidder must do this in terms of the following legislations:

- The application of the Control of Access to Public Premises and Vehicle Act 53 of 1985, Section 2, 3 and 4, as well as; C5.

Stage 2 – Price & preference

The 80/20 preference points System will be used, where 80 points will be allocated to price and 20 points to specific goals. A certified B-BBEE certificate issued by an accounting officer as contemplated in the CCA or SWORN affidavit compliance in accordance with MBD 6.1 must be included. The bidder shall submit proof of Locality within the province or municipal area via a municipal account for the bidding entity. Tenderers should provide proof of registration with the Central Supplier Database (CSD).

SPECIAL REQUIREMENTS

- The Security guards on duty shall always be appropriately dressed with a uniform displaying his/her name, company name, handcuffs, pepper sprays, a torch, portable radio and a baton.
- The Security guards must be equipped with a two-way radio, which is linked to their

headquarters and the rest of the security staff.

- A fully equipped office in Hartswater is a requirement. Information with regard to the means of communication with the regions must be provided.
- The service provider should at all times maintain an up-to-date attendance register of staff per site (this should be submitted with invoices for payment).
- A copy of the monthly report of all sites shall be submitted monthly to the internal security unit of the Department.
- The Phokwane Local Municipality reserves the right to increase or decrease security guards or alter the guard category at any existing or new location.
- The service provider is strongly encouraged to use a locally based labour force for the convenience of the service provider to fulfil the contractual obligations.

DEFINITION OF DIFFERENT CATEGORIES OF SECURITY OFFICERS

Security Officer Means a security officer, grade B, or C **Security officer grade B:** means an employee who performs any one or more of the following duties, namely supervising, controlling, instructing or training security officers, grade C or general workers and reporting thereon to an employee or any other specified person, and who may- a) Drive a motor vehicle in the performance of any or all of the employee's duties; b) Be called upon to perform any or all of the duties of a security officer, grade C.

Security officer grade C: means an employee who performs any or more of the following duties:

- Controlling or reporting on the movement of persons or vehicles through checkpoints or gates;
- Searching persons and if necessary, restraining them;
- Supervising or controlling Security Officers,
- Searching goods or vehicles.

REGISTRATION WITH THE PRIVATE SECURITY INDUSTRY REGULATORY AUTHORITY (PSIRA)

Bidders must provide full details of PSIRA registration for both the company and its directors (owners). Copies of PSIRA registration certificates and/ or any other document(s) must be certified, if not, the bid will be invalid. Proof must be provided annually that all security guards/ relief guards employed are registered with PSIRA.

All security officers as well as all relief and replacement staff should also obtain security clearance with SAPS and copies of such clearances must be provided to Departmental Supply Chain Management at Phokwane Local Municipality within 21 days from the official notification of acceptance of offer.

CONDITIONS OF THE CONTRACT

1. The security personnel provided shall be the employees of the Contractor and all statutory liabilities will be paid by the contractor such as ESI, PF, Workmen's Compensation Act, etc. The list of staff going to be deployed shall be made available to the municipality and if any change is required on part of the municipality fresh list of staff shall be made available by the agency after each and every change.

2. The contractor shall abide by and comply with all the relevant laws and statutory requirements covered under Labour Act, Minimum Wages and (Contract Labour (Regulation & Abolition Act 1970), EPF etc. with regard to the Security personnel engaged by him for works. It will be the responsibility of the contractor to provide details of manpower deployed by him, in the municipality and to the Labour municipality.

3. As far as EPF is concerned, it shall be the duty of the Contractor to get EPF code number allotted by RPFC against which the PF subscription, deducted from the payment of the personnel engaged and equal employer's amount of contribution should be deposited with the respective PF authorities within 7

days of close of every month. Giving particulars of the employees engaged for the municipality works, is required to be submitted to the municipality. In any eventuality, if the contractor failed to remit employee/employer's contribution towards PF subscription etc. within the stipulated time municipality is entitled to recover the equal amount from any money due or accrue to the Contractor under this agreement or any other contract with RPFC, with an advice to RPFC, duly furnishing particulars of personnel engaged for the municipality.

4. The antecedents of security staff deployed shall be got verified by the contractor from local police authority and an undertaking in this regard to be submitted to the municipality and municipality shall ensure that the contractor complies with the provisions.

5. The Contractor will maintain a register on which day to day deployment of personnel will be entered. This will be countersigned by the authorized official of the municipality. While raising the bill, the deployment particulars of the personnel engaged during each month, shift wise, should be shown. The Contractor has to give an undertaking (on the format), duly countersigned by the concerned official of the municipality, regarding payment of wages as per rules and laws in force, before receiving the 2nd payment onwards.

6. All liabilities arising out of accident or death while on duty shall be borne by the contractor.

7. Adequate supervision will be provided to ensure correct performance of the said security services in accordance with the prevailing assignment instructions agreed upon between the two parties. In order to exercise effective control & supervision over the staff of the Contractor deployed, the supervisory staff will move in their areas of responsibility.

8. The appointed company must report monthly on the challenges they faced with the safety and security of the sites. They must report on the conditions they have to work in and must identify shortfalls on the municipality's side where the Municipality could improve the safety measures etc. Monthly reports must be attached with the invoices.

9. Contractor and its staff shall take proper and reasonable precautions to preserve from loss, destruction, waste or misuse the areas of responsibility given to them by the municipality and shall not knowingly lend to any person or company any of the effects of the municipality under its control.

10. The security staff shall not accept any gratitude or reward in any shape.

11. The contractor shall have his own Establishment/set up/mechanism/Training institute to provide training aids or should have tied up with a training institute, with 2-3 Ex-Servicemen/Ex-Para Military Forces/Ex-Police for training purpose at his own cost to ensure correct and satisfactory performance of his liabilities and responsibilities under the contract.

12. Under the terms of their employment agreement with the Contractor the Security staff shall not do any professional or other work for reward or otherwise either directly or indirectly, except for and on behalf of the Contractor.

13. That in the event of any loss occasioned to the municipality, as a result of any lapse on the part of the contractor which will be established after an enquiry conducted by the municipality, the said loss can claim from the contractor up to the value of the loss. The decision of the Municipal Manager will be final and binding on the agency.

14. The contractor shall do and perform all such Security services, acts, matters and things connected with the administration, superintendence and conduct of the arrangements as per the direction enumerated herein and in accordance with such directions, which the municipality may issue from time to time and which have been mutually agreed upon between the two parties.

- 15.** The municipality shall have the right, within reason, to have any person removed that is considered to be undesirable or otherwise and similarly Contractor reserves the right to change the staff with prior intimation to the municipality.
- 16.** The contractor shall be responsible to maintain all property and equipment of the municipality entrusted to it.
- 17.** The contractor will not be held responsible for the damages/sabotage used to the property of the municipality due to the riots/mobs' attack/armed dacoit activities or any other event of force majeure.
- 18.** The contractor will deploy supervisors as per the need given by the municipality. The supervisor shall be required to work as per the instructions of municipality.
- 19.** The personnel engaged have to be extremely courteous with very pleasant mannerism in dealing with the Attendants and should project an image of utmost discipline. The municipality shall have right to have any person removed in case of staff complaints or as decided by representative of the municipality if the person is not performing the job satisfactorily or otherwise. The contractor shall have to arrange the suitable replacement in all such cases.
- 20.** The shifts generally will be determined by the service provider, however a clear record of site hand-over must be kept for accountability purposes. But the timings of the shift are changeable and shall be fixed by the municipality from time to time depending upon the requirements.
- 21.** Shift arrangements will be the responsibility of the appointed company.
- 22.** The contractor shall abide by and comply with all the relevant laws and statutory requirements covered under various laws such as Labour Act, Minimum Wages Act, Contract Labour (Regulation and abolition) Act, EPF, ESI and various other Acts as applicable from time to time with regard to the personnel engaged by the contractor for the municipality.
- 23.** The payment would be made at the end of every month based on the actual shift manned/operated by the personnel supplied by the contractor and based on the documentary proof jointly signed by the representative of the municipality and the contractor/his Representative/personnel authorized by him. No other claim on whatever account shall be entertained by the municipality.
- 24.** Any damage or loss caused by contractor's persons to the municipality in whatever from would be recovered from the contractor.
- 25.** The unit managers must assist the municipality with the giving of basic training/familiarization of the Security and door keeping services required to be done by the personnel to be deployed by the contractor under the contract for 2 to 3 days and this period will not be counted as shift manned by contractor's personnel for the purpose of payment under the contract.
- 26.** (a) In case any of contractor's personnel(s) deployed under the contract is (are) absent, a penalty equal to double the wages of number of guards/supervisors absent on that particular day shall be levied by the municipality and the same shall be deducted from the contractor's bills.
- (b) In case any of contractor's personnel deployed under the contract fails to report in time and contractor is unable to provide suitable substitute in time for the same it will be treated as absence and penalty as mentioned in point 27(a) shall be levied.
- (c) In case any public complaint is received attributable to misconduct/misbehaviour of contractor's personnel, a penalty of R500.00 for each such incident shall be levied and the same shall be deducted from contractor's bill. Further the concerned contractor's personnel shall be removed from the municipality system immediately.

- a. In case the contractor fails to commence/execute the work as stipulated in the agreement or unsatisfactory performance or does not meet the statutory requirements of the contract, municipality reserves the right to impose the penalty as detailed below:-
- i) 20% of cost of order/agreement per week, up to four weeks delays.
 - ii) After four weeks delay Principal Employer reserves the right to cancel the contract and withhold the agreement and get this job be carried out preferably from other contractor(s) registered with DGR and then from open market or with other agencies if DGR registered agencies are not in a position to provide such Contractor(s). The difference if any will be recovered from the defaulter contractor and also shall be black listed for a period of 4 years from participating in such type of tender and his earnest money/security deposit may also be forfeited, if so warranted.

27. The contractor shall ensure that its personnel shall not at any time, without the consent of the municipality in writing, divulge or make known any trust, accounts matter or transaction undertaken or handled by the municipality and shall not disclose to any information about the affairs of municipality. This clause does not apply to the information, which becomes public knowledge.

28. Any liability arising out of any litigation (including those in consumer courts) due to any act of contractor's personnel shall be directly borne by the contractor including all expenses/fines. The concerned contractor's personnel shall attend the court as and when required.

29. The contractor shall deploy duly qualified personnel as per PSIRA regulations, the municipality shall be informed at least one week in advance.

30. Force Majeure

If at any time during the currency of the contract, either party is subject to force majeure, which can be termed as civil disturbance, riots, strikes, tempest, acts of God etc. which may prevent either party to discharge his obligation, the affected party shall promptly notify the other party about the happening of such an event. Neither party shall by reason of such event be entitled to terminate the contract in respect of such performance of their obligations. The obligations under the contract shall be resumed as soon as practicable after the event has come to an end or ceased to exist. The performance of any obligations under the contract shall be resumed as soon as practicable after the event has come to an end or ceased to exist. If the performance of any obligation under the contract is prevented or delayed by reason of the event beyond a period mutually agreed to if any or seven days, whichever is more, either party may at its option terminate the contract.

31. The contractor shall have his own Establishment/Setup/Mechanism, etc. at his own cost to ensure correct and satisfactory performance of his liabilities and responsibilities under the contract.

32. "NOTICE TO PROCEED" means the notice issued by the municipality to the contractor communicating the date on which the work/services under the contract are to be commenced.

33. If the contractor is a joint venture/consortium/group/partnership of two or more persons, all such persons shall be jointly and severally liable to the municipality for the fulfilment of the terms of the contract. Such persons shall designate one of them to act as leader with authority to sign. The joint venture/consortium/group/partnership shall not be altered without the approval of the municipality.

34. The contract period is thirty-six (36) months from the date of the commencement (as mentioned in Notice to Proceed).

35. During the course of contract, if any contractor's personnel are found to be indulging in any corrupt practices causing any loss of revenue to the municipality shall be entitled to terminate the contract forth with duly forfeiting the contractor's Performance Guarantee.

36. In the event of default being made in the payment of any money in respect of wages of any person deployed by the contractor for carrying out of this contract and if a claim therefore is filed in the office of the Labour Authorities and proof thereof is furnished to the satisfaction of the Labour Authorities, the municipality may, failing payment of the said money by the contractor, make payment of such claim on behalf of the contractor to the said Labour Authorities and any sums so paid shall be recoverable by the municipality from the contractor.

37. If any money shall, as the result of any instructions from the Labour authorities or claim or application made under any of the Labour laws, or Regulations, be directed to be paid by the municipality, such money shall be deemed to be payable by the contractor to the municipality within seven days. The municipality shall be entitled to recover the amount from the contractor by deduction from money due to the contractor or from the Performance Security.

38. The contractor shall not engage any such sub -contractor or transfer the contract to any other person in any manner.

39. The contractor shall indemnify and hold the municipality harmless from and against all claims, damages, losses and expenses arising out of, or resulting from the works/services under the contract provided by the contractor.

40. The contracted service provider shall not employ any person below the age of 18 yrs. And above the age of 60 years this include complying with COVID-19 regulations for security personnel employed.

41. JURISDICTION OF COURT

The courts at Hartswater shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

NB: Failure to comply with these conditions will result in your offer being disqualified. All above mentioned conditions are compulsory.

1.2: TENDER CONDITIONS AND INFORMATION

1. General and special conditions of contract

The general conditions of contract (GCC) as well as special conditions of contract (SCC) forming part of this set of tender documents will be applicable to this tender in addition to the conditions of tender. Where the GCC and SCC are in conflict with one another, the stipulations of the SCC will prevail.

2. Acceptance or Rejection of a tender

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept part of it. The municipality does not bind itself to accepting the lowest tender or the tender scoring the highest points. The municipality reserves the right to waive any requirements as contained in the bid conditions and or specifications.

3. Validity Period

Bids shall remain valid for ninety (90) days after the tender closure date.

4. VAT

Price(s) quoted must be firm and must be inclusive of VAT.

5. Registration on central supplier database

It is expected of all prospective service providers who are not yet registered on the central supplier database to register without delay on the prescribed form. The municipality reserves the right not to award tenders to prospective suppliers who are not registered on the database.

6. Completion of Tender Documents

- a) The original tender document must be completed fully in black ink and signed by the authorised signatory to validate the tender. Failure to do so will result in the disqualification of the tender.
- b) Tender documents may not be retyped. Retyped documents will result in the disqualification of the tender.
- c) The complete tender document must be returned. Missing pages will result in the disqualification of the tender.
- d) No unauthorized alteration of this set of tender documents will be allowed. Any unauthorized alteration will disqualify the tender automatically. Any ambiguity has to be cleared with contact person for the tender before the tender closure.

7. Compulsory Documentation

7.1 Tax Clearance Certificate

- a) A copy of a Tax Compliance Status Pin or a Tax Compliance Certificate, printed from the South African Revenue Service (SARS) website, must accompany the bid documents. The onus is on the bidder to ensure that their tax matters with SARS are in order.
- b) In the case of a Consortium/Joint Venture every member must submit a separate Tax Compliance Status Pin and a Tax Compliance Certificate, printed from the SARS website, with the bid documents.
- c) If a bid is not supported by a Tax Compliance Status Pin and a Tax Compliance Certificate as an attachment to the bid documents, the Municipality reserves the right to obtain such documents after the closing date to verify that the bidder's tax matters are in order. If no such

16. Contact with Municipality after Tender Closure Date

If a bidder wishes to bring additional information to the attention of Phokwane Local Municipality, it should do so in writing. Any effort by the firm to influence Phokwane Local Municipality in the bid evaluation, bid comparison or contract award decisions may result in the rejection of the bid.

17. Opening, Recording and Publications of Tenders Received

- a) Tenders will be opened on the closing date immediately after the closing time specified in the tender documents. If requested by any bidder present, the names of the bidders, and if practical, the total amount of each bid and of any alternative bids will be read out aloud.
- b) Details of tenders received in time will be recorded in a register which is open to public inspection.
- c) Faxed and late tenders will not be accepted.

18. Evaluation of Tenders

Tenders will be evaluated in terms of their responsiveness to the tender specifications and requirements as well as such additional criteria as set out in this set of tender documents.

19. Procurement Policy

Bids will be evaluation in terms of the 80 (price) /20 (specific goals) preferential point system. Bids will be awarded in accordance with the Preferential Procurement Regulations, 2001 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000 and its amendments as well as the Municipality's Supply Chain Management Policy.

20. Contract

21. Subcontracting

22. Language of Service Provider

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

23. Extension of Contract

The contract with the successful bidder may be extended on the basis of performance with a period not exceeding 15% of the original contract.

24. Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

25. Past Practices

- a) The bid of any bidder may be rejected if that bidder or any of its directors have abused the municipality's supply chain management system or committed any improper conduct in relation to such system.

1. Definitions	1. The following terms shall be interpreted as indicated: 1.1 “Closing time” means the date and hour specified in the bidding documents for the receipt of bids. 1.2 “Contract” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein. 1.3 “Contract price” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations. 1.4 “Corrupt practice” means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution. 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally. 1.6 “Country of origin” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components. 1.7 “Day” means calendar day. 1.8 “Delivery” means delivery in compliance of the conditions of the contract or order. 1.9 “Delivery ex stock” means immediate delivery directly from stock actually on hand. 1.10 “Delivery into consignees store or to his site” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained. 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA. 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

Incidental Services	13.1 The provider may be required to provide any or all of the following services, including additional services, if any, specified in SCC: a. performance or supervision of on-site assembly and/or commissioning of the supplied goods; b. furnishing of tools required for assembly and/or maintenance of the supplied goods;

	c. furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods; d. performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and e. training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods. 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
14. Spare parts	14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier: (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and (b) in the event of termination of production of the spare parts: i. Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and ii. following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.
15. Warranty	15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination. 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC. 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

	15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser. 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.
